As the nation's largest organization of U.S. military veterans, The American Legion is deeply concerned about American national security, to include terror attacks on our soil.



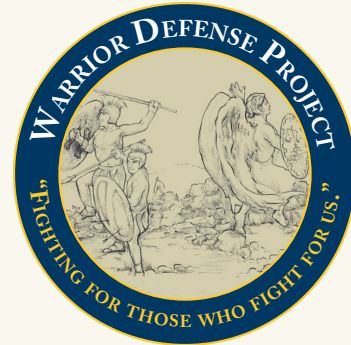
CONFERENCE FOCUS
